Collection not included in price. **Collection fee is \$200.00** – this amount include the shipping container. The mare's owner agrees to pay for the shipment of the semen. No seamen will be shipped until full payment is done. Cheque, credit card or e-transfer payable to Sandra Laprise. Credit card transactions will be charge an additional 4%.

Collection days: **7 days a week** call 613-577-2008 to order semen before 8:30 am same day.

Mare shall be healthy and in sound breeding condition, in case of illness or injury the mare's owner agrees that suitable course of treatment may be undertaken by the stallion's owner's veterinarian, at the mare's owner's expense.

A copy of the mare's registration papers must be sent to the stallion's owner with the contract

A breeding certificate will be issued to the mare's owner **after all expenses have been paid**, and with the **notification of the birth of the foal**.

The stallion's owner **guarantees a live foal**, defined as one that stands, nurses and lives for 10 days; if a live foal does not result from this mating the first year, the mare's owner is entitled to a return privilege for the next two years; **this contract is a Three(3)-YEAR contract**.

If the mare aborts, **a veterinary certificate must be produced** within one week after abortion, declaring the cause of abortion.

In the case where the stallion becomes unfit for breeding, dies, or get sold, and fresh semen is no longer available, \$300.00 will be refunded.

The stallion's owner **shall not be responsible or liable** for any lost shipments of semen or any accident, illness or injury to the said mare or her foal, nor for a mare not conceiving. Insurance of the mare and foal is the mare's owner's responsibility.

It is agreed that this contract shall **not be assigned or transferred** by either party hereto.

When two copies of this contract are signed by both parties, it will then be a binding contract on both parties, subject to the above terms and conditions.
